Representative Matters

Development of 7.3-Acre Parcel

Representation of Greystar Real Estate Partners in the development of a 7.3-acre parcel at New Jersey Avenue SE and I Street SE in Washington, D.C. Our work included development, land use, permitting and zoning matters for the project, which calls for a 10-story, 200-room hotel with ground-floor retail and two residential buildings.

Acquisition of 25-Acre for Development

Representation of Greystar Real Estate Partners in the acquisition of a 25-acre, 10-parcel site and subsequent development of Everleigh Cape Cod, a 225-unit, four-story apartment complex designed for independent adults over age 55, in Hyannis, MA.

Acquisition of 42-Acre Urban Parcel for Redevelopment
